ITEM A - Report on Goals

Goal #1

By using the School Land Trust monies to improve technology usage in our school, we hope to maintain or improve our school Language Arts, Math, and Science standardized assessment scores. Our hope is that as we continue to improve technology use in these subject areas, content will be more effectively and efficiently delivered to our students and they will be able to retain more content. Utilizing Core Knowledge Guidelines will provide our teachers with important information as they prepare and teach their students. Prior testing allows them to see where their students are and what needs to happen so that they reach the next mastery level benchmark. We believe that this practice will assist our students in achieving higher scores as they move through the curriculum.

Identified academic area(s): Technology

This was the action plan.

- 1) American Preparatory Academy (APA) has a Technology Plan that includes a computer replacement schedule so that our stock does not become outdated and need replacing at one time. Draper 2 is due to replace one computer lab this year. 30 Macbook computers with a mobile cart will cost approximately \$32,099.
- 2) American Preparatory Academy (APA) has a Technology Plan that includes a computer replacement schedule so that our stock does not become outdated and need replacing at one time. Draper 2 is due to replace 39 staff computers this year. 39 Macbook computers with chargers and dongles will cost approximately \$45,144.
- 3) American Preparatory Academy has a Technology Plan that includes having Audio Communication Systems in each classroom. This helps teachers better deliver content material and curriculum. Draper 2 has 30 classrooms in need of audio enhancements to the existing Audio Communication Systems. 30 audio enhancements with cable runs and switches will cost approximately \$65,960.
- 4) Apple TV's will be added to 5 classrooms to improve technology and teacher presentation to the students. The approximate cost for this is \$1,848.
- 5) Teachers will use assessment data they collect throughout the year to determine mastery of Common Core State Standards (CCSS) and will teach to mastery. Academic teams will use assessment data in their decisions to make technological changes to their content delivery and online practice time.

Please explain how the action plan was implemented to reach this goal.

- 1. American Prep purchased a new computer lab with a mobile cart with 30 MacBook Air computers for \$24,959. This resulted in a savings of \$7,140 from our original estimate. This discounted price was realized due to the quantity that the district purchased and may not reflect future pricing.
- 2. American Prep purchased 39 staff computers for \$32,060. This resulted in a savings of \$13,084 from our original estimate. This discounted price was realized due to the quantity that the district purchased and may not reflect future pricing.
- 3. American Prep updated the audio enhancement in 30 classrooms for \$88,842.26. This costed APA \$22,882.26 more than our original estimate. Due to other savings realized, we were able to pay more for the audio enhancement.
- 4. American Prep purchased 5 apple TV's for \$784.89. This resulted in a savings of \$1,063.11 from our original estimate. This discounted price was realized due to the quantity that the district purchased and may not reflect future pricing.
- 5. Teachers will use assessment data they collect throughout the year to determine mastery of Common Core State Standards (CCSS) and will teach to mastery. Academic teams will use assessment data in their decisions to make technological changes to their content delivery and online practice time.

Identified academic area(s): Language Arts, Math, Science

This was the action plan.

- 1) American Preparatory Academy (APA) will purchase 30 White Boards with US Map for \$570.
- 2) American Preparatory Academy (APA) will purchase 36 sets of Saxon for \$1,181.
- 3) APA will purchase 40 Clocks for \$2,200.
- 4) APA will purchase 24 3D figures for \$552.
- 5) APA will purchase 36 Molecule Kits for \$720.
- 6) APA will purchase new curriculum supplies for 6th grade science for \$777.
- 7) Teachers will use assessment data they collect throughout the year to determine mastery of Common Core State Standards (CCSS) and will teach to mastery

Please explain how the action plan was implemented to reach this goal.

- 1) APA purchased 30 white boards for \$654.20. This was \$84.2 more than our original estimate. The difference came from picking white boards that would be more durable.
- 2) APA purchased 36 sets of money for Saxon for \$1,180.08.
- 3) APA purchased 40 clocks for \$2,179.60.
- 4) APA was unable to purchase 3D figures.
- 5) APA purchased 36 Molecule Kits for \$718.20.
- 6) APA purchased new curriculum supplies for 6th grade science for \$468.93. This resulted in a savings of \$308.07 from our original estimate. This was a result of some of the items needed being out of stock and unable to purchase.
- 7) Teachers will use assessment data they collect throughout the year to determine mastery of Common Core State Standards (CCSS) and will teach to mastery.
